Tech Nation administers endorsements for the **Global Talent Visa**, enabling the best tech talent from around the world to build their careers in the UK.

Tech Nation is the official Home Office designated endorsing body authorised to assess endorsement applications from individuals with expertise in digital technology and who want to come to the UK under the Global Talent Visa.

Exceptional Talent

For those who are established in their career (5+ years), have a track record of impact and innovation as an employee or founder and the wider respect of your industry or backed by a strong academic record.

Eligible for permanent residency after 3 years



Exceptional Promise

For those who may be at an early stage in their career (less than 5 years) and have already proved the potential to make an early impact as an employee or founder or backed by a strong academic record.

Eligible for permanent residency after 5 years



Intended Applicants

The Global Talent Visa is open to talented professionals with **technical** or **business skills** in the digital technology sector wishing to **work, live and thrive** in the UK.



Technical applicants

must demonstrate proven technical expertise with the latest technologies in building, using, deploying or exploiting a technology stack and building technical infrastructure.



Business applicants

must demonstrate proven commercial, investment, or product expertise in building digital products or leading investments in significant digital product businesses.

Stage 1 - Applying for Endorsement



Review the Home Office Official Guidance and Tech Nation Visa Guide

Complete the online Home Office Application for Endorsement form
Includes payment of fees

Submit your Tech Nation Application for Endorsement form
Upload supporting evidence

Tech Nation will assess your application for endorsement within approximately 8 weeks

If you are endorsed, Tech Nation will notify the Home Office, who notify you

In the event you are not successful,
you have 3 options

1. Apply for a review: Complete a Review Form and
Tech Nation will reconsider your application








2. Re-apply through the same route,
which allows you to add new evidence

3. Apply for entry through another route

Stage 2



After a successful endorsement,
apply for a visa through the Home
Office, Tech Nation are not involved
in this process

-  **Uncapped availability**
No quota on endorsement. Applications open all year-round to exceptional tech talent
-  **Flexibility**
No job offer is required. Switch jobs or start your own venture without the need for further authorization
-  **Launch your career**
No sponsorship licence necessary. Be empowered to explore career opportunities without being tied to a specific employer
-  **Amazing network**
Join a friendly alumni community of world leading tech professionals
-  **Family friendly**
Your immediate family can come with you
-  **Extend**
Extend your Global Talent Visa when needed Keep the other benefits as they are
-  **Pathway to citizenship**
After the initial visa period, Global Talent Visa holders can either apply for an extension or permanent settlement in the UK after 3 or 5 years

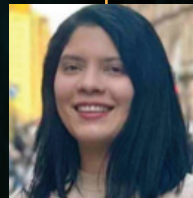
