Letter of Support: Empowering Savers and Backing British Businesses

As part of Founders Forum Group, Tech Nation represents a community of the UK's most ambitious founders and high-growth businesses. A core part of our mission is to convene entrepreneurs, investors, corporate leaders, and policymakers to champion the conditions that allow innovation to thrive.

We believe that connecting the British public to British-founded companies is a powerful way to drive long-term prosperity. ISA reform presents a unique opportunity to achieve this – unlocking growth for both savers and founders through a multi-part approach.

While a reduction in the tax-free allowance for cash ISAs may encourage more investment, it will only be effective if introduced alongside new investment routes that ensure redirected savings genuinely support British innovation. We are calling for the creation of dedicated mechanisms within the ISA system that channel capital into UK tech and growth-stage businesses, as well as an expansion of ISA eligibility to include investment in UK innovation funds. Together, these steps would provide assurance that savings are being used to back British-founded companies, scale future UK unicorns, and fuel the growth of the wider economy.

Furthermore, for this to succeed, it must be a shared national effort. It Takes A Tech Nation – founders, Big Tech, corporates, investors, and government working together to champion British-founded companies, celebrate their successes and bring them into the spotlight. This crucial collaboration will help optimise returns for investors while producing jobs, innovation, and prosperity across the country.

British people could be making more of their money, growing their wealth through investment – and at the same time, helping to power the growth of British-founded companies. Someone who put £1,000 into a cash ISA every April since 1999 would have around £34,000 today, but the same investment in a stocks and shares ISA could have grown to around £83,000. Meanwhile, the FTSE has risen 60% in the past five years – clear proof that those who invest in British businesses share in their success.

The opportunity now is to reshape the ISA environment so that it not only benefits savers, but also strengthens the backbone of our economy: UK innovation and entrepreneurship.

Reforming ISAs in this way would empower savers to grow their wealth while investing in the future of the UK economy – a model that rewards ambition, supports founders and keeps Britain at the forefront of global innovation.
